

# Saville Studios Holiday Market 2016

The 6<sup>th</sup> Annual Art Studio Holiday Market will host local vendors as an open-to-the-public sale.

## **ELIGIBILITY AND POLICES:**

1. Be 18 years or older and sell your own product line. Absolutely no sales reps, no exceptions. Essential Oils reps are not permitted to "sell" oils they have made to book shows. Only 2 styles of vendor permitted per show (for example, only 2 jewelry lines, etc.)
2. Be present with work for the duration of the show. Artists may not break down displays or leave prior to closing time on any day of the Market; artists will not be allowed to return the following day or to any future Saville shows unless proof of an emergency is provided.
3. This is a family oriented show. The Market Committee reserves the right to ask the artist to remove questionable work including erotic and macabre art.
4. No animals are allowed in exhibit areas -inside or out, other than those providing assistance to persons with disabilities.
5. The Market dates are rain or shine.
6. All sales will be handled by the exhibitor. Georgia sales tax (7%) should be collected by the exhibitor.
7. The Market committee reserves the right to refuse exhibition of work not consistent with submitted images and/or these guidelines. The interpretation of the Market rules is solely the discretion of the Saville Art Studios.
8. Vendors are responsible for protection of their art, materials and displays and for proper insurance. Vendors will be held liable for any damage made by any part of their display.

**FEES:** Artist - \$65 Outdoor /// Food Vendors- \$85 (Electricity included). Application not considered submitted without fee payment. Refund given for those not accepted to Market.
